- 4. Treasurer's Report (Q1 full report) Craig Lending and Florence Jessup
 - September Report
 - Income
 - Compared with Prior Year (PY), overall month's Income Categories are ahead with both its monthly results and Year-to-date (YTD) time progression.
 - Pledge Income Monthly Giving was 14.84% of Full Year Budget (FYB), while YTD was 46.98%. This result was \$67.24k more than Prior Year month and \$33.5k more PY YTD.
 - Other Ops Generated Income Monthly result was 13.21% of FYB, while YTD was 22.70%. This result was (\$757) less than PY month's result, but (\$1.4k) less than PY YTD.
 - Transferred from Restricted is more than September prior YTD by \$2.5k.
 - Expenses
 - Full year Expenses are lower than period progression, i.e. 21.71%. YTD Expense total is \$266.5k (vs. PY YTD \$255.2k), i.e. increase in spending by (\$11.3k).
 - Net Income

- The month's Net Income (NI) was \$58.48k vs. PY (\$3.3k), while YTD NI total was \$221.05k vs. PY YTD \$187.75k, i.e. a gain of \$33.31k.
- Balance Sheet
 - The month's YTD Balance Sheet Financial Assets values has increased \$663.1k. This is primarily due to market gains to the income endowment fund.
 - 1Q Reconciliation: Income Endowment (IE) has grown due to Market Performance by \$526.57k.
 - 1Q Reconciliation: Common Fund (CF) value grown by \$46.81k.
- Board Restricted Funds
 - Performance Net = **\$570,908.78**
 - a. Income Endowment Fund **\$587,422.66** (increase due to 1Q Reconciliation)
 - b. Operating Cash Reserve **\$0.00**
 - C. Property Maintenance and Improvement Fund (\$16,513.88)

- 5. Minister's Report
 - Stewardship campaign Fall wave update (Florence Jessup)
 - Decisions taken on a few years ago:
 - Face to Face conversations incorporated into the stewardship process, attempt to reach 1/3 of congregation every year
 - Split the campaign into two waves to spread out the work
 - This year, it will go back to a single Stewardship campaign starting in February
 - The Fall campaign met its goals and is on track to exceed the overall goal
 - Personnel Update
 - Amanda Graff has been hired as the permanent Director of Religious Education with a small salary adjustment.
 - A new Admin Assistant will begin on Monday the 18th. This position will report to the Office Manager. This is a 25 hour per week position.
 - The communications position is still vacant.
 - Brief discussion of political discourse and statements that can be made while representing the Church

- Health insurance 0
 - Despite making very conservative projections last year, we will be over budget on staff Health Insurance by approximately \$14K.
 - Florence is looking at other options for the future, but predictions are difficult to make . right now. It is likely that this will continue to be a rising cost.
